# AGENCY IN CHARGE

The Department of Health (DOH) is the primary agency advocating the implementation of the MISP-SRH with affected local government units in times of disasters and humanitarian crises, the DOH:

1. Activates the Reproductive Health Coordinating Teams (RHCTs) and implements the MISP in their locality. You may contact your regional Center for Health and Development or the Local Government in the affected disaster area for coordination.

Structure of Local Reproductive Health Coordinating Team

i.Chair: PHO/MHO/CHO

ii.Co-chair: Humanitarian Partner in SRH

iv.Local Health Office and Social Welfare Chief Hospitals, Women and Children Protection Unit (WCPU), Local PNP (WCPD Officer), Local DRRMO, Local Government Operations Officer, Sangguniang Kabataan (SK), CSOs/NGOs, Local Nutrition Action Officers, Association of Barangay Captains.

2. Links pregnant women including adolescents to health service providers

3. Engages people and groups among communities to disseminate risk information on SRH

4. Provides counterpart budget for prepositioning RH supplies and commodities, capacity building, local service providers, and meetings on MISP-related activities

5. Records the status of MISP indicators in the LGU scorecard for the Seal of Good Governance

Minimum Initial Service Package (MISP) for Sexual and Reproductive Health (SRH) is a set of basic reproductive health services designed to "prevent maternal and neonatal mortality, morbidity and disability, reduce HIV transmission, prevent and manage sexual violence among populations affected by disasters in a humanitarian crises, particularly women and girls."

## **IMPORTANCE OF MISP**

Conflicts and disasters disproportionately affect women/girls and their children raising risks to health and wellbeing due to the abrupt loss of basic health services, magnified cases of malnutrition, disease, trauma, and violence. Pregnant women and girls in emergencies may give birth without the most basic support for a safe and clean delivery.



## MISP OBJECTIVES

During the onset or in times of imminent disaster the following are the objectives of MISP Proponents.

Ensure the health sector/cluster identifies an organization to lead the implementation of the MISP

Prevent sexual violence and respond to the needs of survivors

Prevent the transmission of and 3 reduce reduce morbidity and mortality due to HIV and other STIs

Prevent excess maternal and newborn morbidity and mortality

> Prevent unintended pregnancies
