### 1. Reproductive and Family Health Association of Fiji (RFHAF)

### 2. Kiribati Family Health Association (KFHA)

**Mr Amota Tebao**, served as Senior Nurse and Senior trainer in SRHR and family planning at KFHA for over 15 years. Mr Tebao was not only dedicated professional but also a compassionate individual who devoted his life to serving the people of Kiribati with unwavering commitment and expertise.

### 3. Papua New Guinea Family Health Association (PNGFHA)

### 4. Korea Population Health and Welfare Association (KoPHWA)

**Dr Mo-im Kim**, Former Minister of Health and Welfare and 8<sup>th</sup> President of KoPHWA from 1995 -1998, departed on 29 February 2024 at the age of 89.

An academic pioneer and policy leader in the field of health, she received her Ph.D. in health sciences from Johns Hopkins University in 1973 and served as Dean of the College of Nursing at Yonsei University, as Director of the Graduate School of Public Health. She has established integrated curriculum for the International Public Health, the Medical Law, and the Ethical at the Graduate School of Health for the first time in Korea and more than 100 research papers and policy reports were the basis for academic development and policy promotion in the Korean health sciences.

When she became a member of the National Assembly of Republic of Korea in 1981, she participated in many legislative and policy-making processes on health and welfare and women's policies.

Internationally, she has served as a representative of the United Nations World Conference on Women and has played an active role in international organizations such as WHO and IPPF. In 1991, she was selected to be a "Heroes of Public Health" by the Johns Hopkins School of Public Health. In 1996, she was selected as the "Johns Hopkins Society of Scholar".

She has donated her entire property to her alma mater university and practiced the spirit of Noblesse Obligor.
