## **BoT: 15 Trustees**

- NGC received self-assessments from eight trustees so far.
- Three trustees (Daren-Paul; Rada and Karina) joined the Board early in 2024 and therefore were exempted from review.
- NGC did not receive a response from Aurelia who left the Board on 30<sup>th</sup> April 2024.
- NGC is still waiting for the responses from four trustees (Jon, Sami and Rose-Marie) to move to the next step of Board's Chair assessment.

# **CFAR: 5 Members**

- NGC received self-assessment from only the C-FAR Chair.
- NGC still waiting for the remaining four members to complete their selfassessment.
- As soon as self-assessment is completed the NGC will move on with the C-FAR Chair's assessment.

# **CSIP: 6 Members**

- NGC received self-assessments from only three members.
- NGC has not received a response from Sami, the C-SIP Chair.
- Amelia Zawangone resigned from the committee on 23<sup>rd</sup> April and did not complete her self-assessment before leaving.
- The Interim Chair of CSIP (Aurelia Nguyen) terms came to an end on 30<sup>th</sup> April and she did not complete her self-assessment before leaving.

### **RATC: 4 Members**

### MC: 7 Members
